
Don't be afraid to ask the 'dumb' question, everyone else will be relieved you had the guts to ask!

Back to School

If you are new to CRAEA, switched schools, or have had any recent life changes (name change, moved, phone/email) it is important to update your **AEA Learning Online** Profile. It is important you DO NOT create a new account.

To edit personal information:

- Click on the Profile icon near the top of the screen
- Edit any of the fields located under Personal Info, then click Save Personal Info button.

To update your Employment information:

- Click on the Profile icon near the top of the screen
- Edit any of the fields under Employment Info, then click Save Employment Info button
- If you are changing districts (not new to teaching) you will need to change your affiliation
 - Select your district from the list, and enter in the district verification code to prove that you are in the district. To get your code, please reach out to your school administrator or secretary.

We also have a one-page document of extended **Training System directions** to assist you in navigating passwords, training courses, printing certificates, editing personal information, employment information, and additional help.

Iowa Board of Educational Examiners (BOEE) Updates

Beginning July 1, 2023, HF 672 will eliminate renewal credit requirements for licensed educators who have completed a master's degree or higher and have at least 10 years of licensed experience in education. **Applicants will still apply to renew**.

Requirements for eligibility:

- Completed a master's degree or higher.
- Served at least 10 years in education
 - \circ Any PK-12 education experience in which a BoEE license is required
 - Can also include out of state or out of country education experience
 - o Education experience does not need to be after the higher degree has been earned
- Requirements at the time of application for renewal:
 - $\circ\,$ Valid Mandatory Reporter for Child Abuse and Dependent Adult Abuse certificates.
 - Verification of degree. (official transcripts from college/university).
 - Verification of 10 years or more of education (letters on school letterhead from current/previous school districts)
 - Administrators and evaluators will also need to include verification of Evaluator Training less than 10 years old.



Which Mandatory Reporter Training Do I Take?

In 2019, HF 731 modified the requirements for mandatory reporter training for child and dependent adult abuse. Additionally, Iowa HF430 now requires all school employees **18 years and older** to be trained in Mandatory Reporting. Before, the requirement was just for staff licensed through the Board of Educational Examiners. The change in law means custodians, bus drivers, food service personnel, and all other non-licensed staff must take the training. Also, here's a **one-pager** the includes links as well.

Before you start, check your Mandatory Reporter Child Abuse and Mandatory Reporter Dependent Abuse status by logging into the **AEA Learning Online System**. Please scroll down and look for it in your certificate history. Once you have identified your current Mandatory Reporter status, read through the options and select the ones that align with your current certification status.

Option 1:

If you took the Mandatory Reporter: Child Abuse and Mandatory Reporter: Dependent Adult abuse before July 2019 **OR** if your current certificate has expired, you will need to complete the initial trainings:

- Mandatory Reporter: Child Abuse (INITIAL TRAINING)
- Mandatory Reporter: Dependent Adult Abuse (INITIAL TRAINING)

Option 2:

If you took the Mandatory Reporter Child Abuse and Mandatory Reporter Dependent Adult Abuse after July 2019 **and** your current certificates **are still valid**, take the following recertification trainings (Spanish versions now available):

- Mandatory Reporter Child Abuse (RECERTIFICATION)
- Mandatory Reporter Dependent Adult Abuse (RECERTIFICATION)
- Spanish Version Mandatory Reporter Child Abuse (RECERTIFICATION)
- Spanish Version Mandatory Reporter Dependent Adult Abuse (RECERTIFICATION)
